Qualifications

RII30820 - Certificate III in Civil Construction Plant Operations

**(User Choice funding available in QLD and Smart and Skilled
funding available in NSW)**

This nationally recognised qualification will appeal to anyone currently employed or wanting to be employed in the civil construction industry. This course provides training in the practical and technical skills required in a civil construction environment, using a broad range of skills, in a wide variety of situations.

Certificate III in Civil Construction Plant Operations is conducted as on the job training. The training will take place on-site for both the theory and practical components. The structure of this qualification will be negotiated to meet the operational requirements of the business and will include scheduled face to face visits from a trainer who will also provide ongoing support and mentoring via email and telephone for the duration of the program, as well as scheduled training days during which time the student's training progress will be monitored and recorded. Ongoing assessments will be conducted throughout the program and may include completion of activity workbooks, actual or simulated workplace activities, observation of skills and knowledge applied within the workplace, written tests, research projects and informal / formal questioning.

There are no entry requirements for this qualification.

As a Government, Skills Assure Identifier in Queensland, DATS currently holds User Choice funding for RII30820 Certificate III in Civil Construction Plant Operations and is also a Smart and Skilled approved provider in NSW. This means the training provided by DATS is funded to our eligible clients and is delivered through an apprenticeship pathway.

VERIFICATION OF COMPETENCY

Verification of Competency (VOC) is a method of assessment that assists employers to meet WHS requirements and ensure staff are competent to operate equipment or perform a task. National WHS harmonisation laws, effective since January 2012, have brought greater importance to employer's due diligence and obligation to ensure an individual has 'current competency'.

Assessing for VOC enables businesses to confirm that their employees are competent in their skills and using equipment. It is commonly used in many industries for pre-employment checks, contractual arrangements, or site requirements.

No longer is just holding a ticket or qualification enough for an employer to determine an individual is competent. VOC enforcement is new for industry and is subject to interpretation. Working with industry leading clients, DATS has developed a formal process that allows for flexibility to meet our clients' needs whilst maintaining a high standard of assessment.
